

Maybank Regional Golf Program 2026 Terms and Conditions (Philippines)

A. Programme Eligibility

1. The Maybank Regional Golf Programme (“**Programme**”) is organised by Malayan Banking Berhad (Company Registration No. 196001000142) (“**Maybank**”). By participating in this Programme, the Eligible Cardmember(s) (as defined below) hereby expressly agrees to be bound by these terms and conditions (“**Terms and Conditions**”) and any decisions made by Maybank in respect of this Programme shall be final and binding.
2. This Programme is valid from 01 January 2026 to 31 December 2026.
3. Principal Cardmembers of the following cards (refers to “Eligible Cardmember(s)”) issued in Philippines and with an account in good standing order can access this Programme:

4. Eligible Cardmember(s) enjoy complimentary green fees at six (6) golf clubs in Philippines and ninety-four (94) golf clubs overseas (“Participating Golf Clubs”), subject to booking conditions listed hereunder. Selected golf clubs are not accessible on weekends under this Programme. Please contact Maybank Customer Service for more information.
5. Eligible Cardmember(s) can enjoy golf benefits at Participating Golf Clubs by meeting the minimum spending requirement on their previous month's card statement, as shown in the table above.
6. Eligible Cardmember(s) must have an active card status without any overdue payments.

B. Programme Mechanics

1. This Programme will only be applicable when Eligible Cardmember(s) book through Maybank Customer Service.
2. Eligible Cardmember(s) will not be able to enjoy the Programme if utilizing a tee-time booked by a golf club member. Similarly, a golf club member cannot make a booking directly at the Golf Club and transfer the confirmed tee-time over to the Eligible Cardmember(s).
3. For bookings to golf clubs in Philippines, Eligible Cardmember(s) can book a maximum of one (1) flight per booking on a first-come-first-served basis and cannot book for the next golf game until the current booked game has been played.
4. For golf clubs located outside of the country in which the Maybank Card was issued, the Eligible Cardmember(s) can book a maximum of two (2) golf clubs each time on a first-come-first served basis. However, no further bookings will be accepted until the current booked game has been played.
5. Unless otherwise specified, there must be a minimum of two (2) golfers per flight, per booking for Weekday requests, and a minimum of three (3) golfers per flight, per booking for Weekend and Public Holiday requests.
6. The minimum golfer requirement per flight shall apply as required by the respective golf clubs. In the event of incomplete ball-flight(s), the golf club reserves the right to pair up players at its discretion.
7. Selected golf clubs are not accessible on weekends under this Programme. Please contact Maybank Customer Care for more information.
8. Tee time booking period is definitively determined by the individual policies of each Participating Golf Club.
9. All tee times are not an entitlement and are subject to availability.
10. All golf games must be completed by 31 December 2026.
11. **Golf Clubs in Malaysia, Singapore, Indonesia and the Philippines:**
 - i. Eligible Cardmember(s) cannot book for the next golf game until the current booked game is played.
 - ii. Weekday bookings must be made at least four (4) working days in advance and at least six (6) working days in advance for weekend/ local Public Holiday bookings. Bookings cannot be made beyond fourteen (14) working days in advance.

- iii. Up to four (4) Eligible Cardmember(s) can play together in one (1) flight with no paying guest requirement at Participating Golf Clubs, with an exception at the golf clubs listed below.
- iv. **The Els Club Desaru, Forest City Golf Resort, Tropicana Golf & Country Resort, Kuala Lumpur Golf & Country Club, Saujana Golf & Country Club and Sentosa Golf Club:**
 - Each Eligible Cardmember must be accompanied by at least two (2) paying guests.
 - Eligible Cardmember(s) can play up to a maximum of four (4) rounds a year.
 - For bookings at *Saujana Golf & Country Club*, Eligible Cardmembers are required to book at least one (1) night stay at The Saujana Hotel, which is located on-site.

12. Golf Clubs in Thailand, Vietnam and Cambodia:

- i. Each Eligible Cardmember(s) must be accompanied by at least one (1) paying guest.
- ii. Up to a maximum of two (2) Eligible Cardmember(s) can play together in a flight, provided the paying guests and minimum golfer requirements for Weekday, Weekend and Public Holiday are met.
- iii. Weekday bookings must be made at least four (4) working days in advance and at least six (6) working days in advance for weekend/ local Public Holiday. Bookings cannot be made beyond thirty (30) working days in advance.

13. Golf Clubs in Australia, China, Japan, South Africa, Spain, Turkey, United Arab Emirates, United Kingdom, France and the United States of America:

- i. A minimum of three (3) golfers per flight, per booking, is required.
- ii. There must be at least two (2) paying guests for each flight, regardless of the number of Eligible Cardmember(s) in the same booking.
- iii. Bookings must be made at least fourteen (14) working days, but not more than two (2) months in advance of the requested tee-off date, with an exception for golf clubs in Japan.
- iv. Booking at golf clubs in Japan is encouraged to book at least three (3) months in advance due to the short golfing season.
- v. Bookings for Pebble Beach Golf Links require a minimum stay of two (2) nights at any of their properties; one (1) round per day. During peak season, a minimum of three (3) nights' stay is required; one (1) round per day and five (5) nights' stay is required for two (2) rounds. Each room accommodates a maximum of two (2) players.
- vi. Bookings to The Links at Spanish Bay and Del Monte Golf Course require a minimum one (1) night stay at either The Inn at Spanish Bay or The Lodge at Pebble Beach. Each room accommodates a maximum of two (2) players and one (1) round per course daily.

C. Payment

- 1. All payments for green fees and/or applicable charges for Eligible Cardmember(s) and guests must be made upon booking and charged to the Eligible Cardmembers' Maybank Cards. Charges will be reflected on the Eligible Cardmembers' Statements as transactions made at 'Concepts Golf Management Pte Ltd'. Rates quoted are exclusive of taxes and are subject to change without notice.
- 2. Full payment for your golf booking will be charged once your reservation is confirmed. For the avoidance of doubt, full payment refers to green fees (if applicable), caddy and/or buggy, insurance, taxes and any other fees imposed by the golf club.
- 3. Maybank reserves the right to cancel the golf booking if payment for green fees and/or applicable charges is not settled before tee-off.

D. Amendment and Fees

Upon booking confirmation, an amendment fee of **PHP 1500 per change** applies for the following changes to the:-

- i. Player(s) name
- ii. Number of player(s) booked
- iii. Tee time(s)

E. Cancellation Terms

Eligible Cardmember(s) agree to and understand the following policies upon booking confirmation:-

- 1. Cancellation refers to change of date (of play), a no-show or late arrival.
- 2. Eligible Cardmember(s) will be charged for any cancellation or no-show. These charges will be applied directly to Eligible Cardmembers' Maybank card.

3. Subsequent golf bookings will not be permitted until all outstanding fees are paid.
4. The following charges apply to Eligible Cardmember(s) and their Guest(s):-

*Pebble Beach Golf Links, The Links at Spanish Bay & Del Monte Golf Course	<ul style="list-style-type: none"> ▪ A two (2) nights room deposit is due at the time of booking. ▪ Full payment shall be due twenty-one (21) days before arrival. ▪ Change of dates for rooms or golf must be made at least twenty-one (21) days before arrival or date of play, whereby an amendment fee of USD250.00 shall apply. ▪ A full forfeiture of the total charges of the booking will be incurred for any cancellations made less than sixteen (16) days before your scheduled check-in and/or tee off date, whichever is earlier.

F. Other Terms and Conditions for Complimentary Green Fees Programme

1. The Programme cannot be used by Eligible Cardmember(s) or their guests in conjunction with any golf promotion or for participation in any golf tournament and/or corporate/social golf arrangements at the respective clubs.
2. Participating Golf Clubs will not accept direct enquiries and/or bookings for this Programme.
3. Eligible Cardmember(s) are responsible for arranging the minimum number of players required, with a minimum of two (2) players per flight for weekdays and a minimum of three (3) players per flight for weekends, subject to pairing at the golf club's discretion.
4. Eligible Cardmember(s) and his/her guests are required to pay for the use of the buggy, caddy, insurance, taxes or any other fees as imposed by the Participating Golf Club.
5. Eligible Cardmember(s) and his/her guests must have a valid golfer's handicap and an insurance policy at the time of booking of the golf game.
6. Rain checks will not be issued once play has commenced.
7. The Programme is valid for golf course access only and does not constitute a golf club membership. Eligible Cardmember(s) and/or their guests will not have access rights to other facilities at the golf club.
8. Maybank and its vendors do not assume liability and the Cardmember shall not make any claim whatsoever for (i) injury or bodily harm or (ii) loss of or damage to the property, howsoever caused, arising from or in connection with this Programme.
9. Maybank reserves the right to change and/or amend the terms and conditions of this Programme, remove or replace any Participating Golf Club offered in this Programme by giving Twenty-One (21) calendar days ' notice before the implementation.

10. The terms and conditions, rules and regulations of each Participating Golf Club shall apply. Any dispute regarding the terms and conditions, rules and regulations is to be resolved directly with the respective Golf Club.
11. Complimentary green fees under this Programme are subject to a monthly cap as determined by Maybank and/or its appointed vendors. Allocation of complimentary green fees shall be on a first-come, first-served basis and subject to availability for the relevant month. Once the monthly cap has been fully utilized, Eligible Cardmember(s) may still proceed with bookings; however, complimentary green fees shall no longer be applicable, and prevailing green fees and any applicable charges shall be borne by the Eligible Cardmember(s).
