4. Photocopy of BIR Form 2303 - Certificate of Registration;
5. Photocopy of additional valid/government-issued ID (BIR Tax Identification Number (TIN) Card, Passport, Driver's License, SSS/GSIS Card, Company ID, etc.) - with three (3) specimen signatures;
6. Photocopies of business registrations and permits of Real Estate Brokerage, if applicable;
7. Sworn Declaration of Gross Income - with stamped-received of BIR;
8. BIR Certificate of Registration (BIR Form 2303);
9. Official Receipt.
